

Project Here Games | Privacy Policy

Thank you for visiting the Project Here Games website (“the website,” or “the site”). Your privacy is important to Project Here Games. This privacy statement provides information about the personal information that Project Here Games collects, and the ways in which Project Here Games uses that personal information.

Throughout this policy, “Project Here Games,” “We,” and “Our” refer to the Project Here Games team, including its creators, sponsors, and agents, including but not limited to Health Resources in Action, the Massachusetts Office of the Attorney General, and the GE Foundation.

This Privacy Policy should be read in conjunction with the Project Here Games Terms of Service.

Personal information collection

By visiting or using the site, you consent to Project Here Games’ collection, use, and disclosure of the following kinds of personal information:

Personally identifiable information

Project Here Games does not knowingly collect, use, or disclose any personally identifiable information from users visiting the site.

Non-personally identifiable information

Project Here Games, including its team members and subcontractors, may collect, use, and analyze non-personally identifiable information collected from you and your use of the site to perform analyses of user behavior and characteristics, improve the site, or prevent fraud or misuse of the site. Project Here Games also collects and saves all quiz, scenario, and game results in order to display results for users. These results are tied to anonymized, non-personally identifiable usernames and will not be associated with personally identifiable information. Project Here Games and its subcontractors may aggregate these results and use the statistics used to improve the site and for product development and educational analysis purposes, generally.

Third Parties

Project Here Games may disclose aggregated information about user behavior and user results to third parties for explanatory and other purposes, but such statistics contain no

personally identifiable information and will not be used to gather such information. Project Here Games will not sell any information to any third parties, allow third parties to advertise on the site, or allow third parties to directly access user information for purposes unrelated to the educational purpose of Project Here Games.

User Login Data

Project Here Games collects, encrypts, and will not decrypt under any circumstance the following information:

- A password of the user's choice
- Users' answers to security questions, which consist of:
 - What is your favorite color?
 - What is your pet's name?
 - What is your favorite food?

We collect this information so that users can log back into the site and continue an uncompleted play session. This data is encrypted on the disk at rest, and Project Here games has no way of accessing, receiving copies of, or providing decrypted versions of it.

All communication between the server hosting Project Here Games and the user is encrypted using SSL, the industry standard for secure communication.

Cookies and other tracking technology

We do not use cookies or other tracking technology.
